## Please read carefully:

- 1. All dogs must have proof of current rabies, DHLP and Bordetella vaccinations on site in order to enter the waterpark.
- 2. All dogs must wear collar and license in the pool area.
- 3. Aggressive or overly timid dogs, as well as those in heat should be left at home.
- 4. All dogs must be off leash when inside the facility and must be sociable and well behaved.
- 5. Any dog displaying aggressive behavior will be asked to leave (no refund).
- 6. Owner/handler must maintain control of and watch their dog(s) at all times.
- 7. If your dog eliminates on the deck or in grass you are responsible for picking up and disposing in designated trash cans. Bags will be provided.
- 8. Humans are <u>not allowed</u> to swim/wade in the pool.
- 9. Toys and tennis balls may be brought for dogs to play with but if the dog does not retrieve the toy it will not be retrieved.
- 10. Bowls of water will be available on site or you may bring your own to use in the designated area.
- 11. Management reserves the right to ask any dog and handler/owner to leave prior to the end of a session if they are not abiding by the rules.
